Through HEART, Georgia taxpayers can make 100% tax credit-eligible contributions, up to specified limits, to qualified rural hospitals of their choice. "C" Corporations and Pass-Through Entity business owners who participate may also qualify for an additional federal business expense deduction. Essentially, individuals and business have the unique opportunity to pay their state income taxes – an expenditure they are required to make anyway – through contributing to rural hospitals.
